LIBERTARIAN PARTY OF NEW HAMPSHIRE AFFILIATE STATUS**

I have been a member of Libertarian Party national since 1979 and am a current paid national member. I have been a Delaware resident and LP member since 2020. I have been Chair and Secretary of LP Washington DC. I have attended many state and national conferences and meetings in person and online.

For 45 years I have been monitoring Libertarian Party history through LPNews, newsletters, etc. and online. I have lots of material saved. Since 2021 I have managed the account @LPUSAWatch at X.com. (Formerly @MisesExposed)

I do agree the Libertarian National Committee (LNC) should have revoked the Libertarian Party of New Hampshire's (LPNH) affiliate status for reasons named: 1) for supporting Donald Trump, the candidate of another party, against the national bylaws, and 2) for undermining candidates and the party on the national level. The LPNH has made hundreds of extremely bigoted and, even worse, "initiation of force"-type statements since circa 2020.

Jeremy Kauffman, the LPNH's nationally infamous ring leader since that time, may not have been on the LPNH board in 2024. However, he has been LPNH's social media coordinator and defacto spokesperson for years. He was elected secretary of LPNH in 2025 and chair in 2026. He has forwarded many of his own obnoxious X.com/@jeremykauffman postings to X.com/@LPNH.

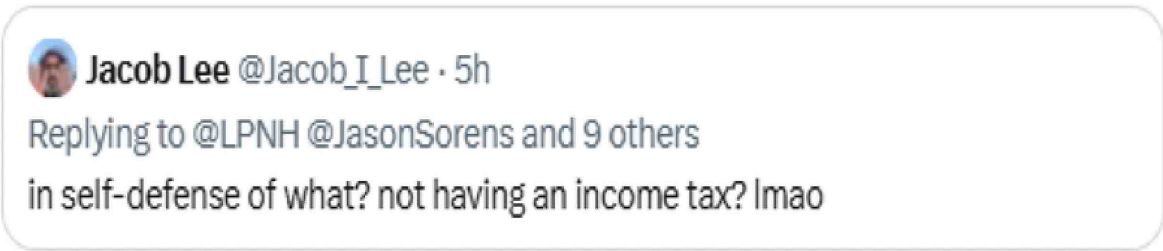
